CL.1. THE MoU

CL.1.1 THIS MoU made and entered into on 22nd day of November Two Thousand Twenty-one between Department of Chemistry, Govt. KRG PG Auto. College, an affiliated autonomous college of Jiwaji University, (hereinafter called KRGC which expression shall where the context so admits include its successors and permitted assigns) of the one part,

And

CL.1.2 Department of Chemistry, Sadhu Vaswani Autonomous College, Bairagarh, Bhopal affiliated autonomous college of Barkatullah University, Bhopal (hereinafter called the SVCB which expression shall where the context so admits include its successors and permitted assigns) of the other part.

CL.2 PREAMBLE

CL.2.1 The Chemistry departments of KRGC and SVCB, have realized the need for a close linkage between the two departments/centres in terms of research and academic activities. In compliance to this idea, both have decided to sign a Memorandum of Understanding (MoU) as per the following terms and conditions:

CL.3 GENERAL

CL.3.1 The faculty of KRGC may participate in the teaching program in the Area of Chemistry of SVCB, if desired so, on request and subject to mutual convenience.

CL.3.2 The faculty of the departments will work towards joint research activities thereby mutually using leading research facilities developed/ to be developed at KRGC and SVCB.

CL.4 ACADEMIC AND DEVELOPMENT PROGRAMMES

CL.4.1 For the mutual benefit of the two departments i.e. KRGC and SVCB there will be exchange of faculty members of the mentioned department (as mentioned at point 3.1) as per mutual convenience.

CL.4.2 KRGC and SVCB faculty members will help each other in preparing common research programmers.

CL.4.3 The students/researchers working at KRGC shall be allowed to use the facilities of SVCB as per the norms of Jiwaji University, Gwalior, if any and vice versa.

CL.4.4 KRGC and SVCB will work closely to generate appropriately trend men power in the related area through skill development program, organization of formal academic curricula, symposia, short term training courses etc.

CL.4.5 Honorarium and TA/DA (if applicable) will be provided to the faculty members as per rules by host organization.

CL.4.6 The faculty of **KRGC** and **SVCB** may apply for joint collaboration research project and patents to the national and international funding agency. Data generated to such collaborative research will be published in peer reviewed journals jointly by the faculty of both the institutions.

CL.5. DURATION OF MoU

This MoU shall be valid for a period of 36 months from the date of signing. The duration may be extended with the consent of both the parties under mutually agreed terms and conditions.

CL.5.1. It is further agreed that the Principal of **SVCB** and Principal/Head of **KRGC**, Gwalior through periodic meetings will monitor the progress of this MoU.

Any change/ modification/termination as introduced/suggested will be abided by both the parties.
